Internet Report 05.2022

On February 1, 2022, SMCC changed its internet provider from AT&T to French Broad EMC and its WiFi management from AT&T to Epsilon-Inc. based in Weaverville. This has resulted in substantial savings with improved speed and service.

During early May the last financial connections to AT&T have ended. Recently we received refunds of \$524.00 from AT&T for internet services and \$258.74; these funds will revert to the 2022 Strategic Partnership Grant from Buncombe County. It is worth noting that AT&T did not charge us an early termination fee for ending our service.

Our service with French Broad and Epsilon has been superlative. There have been very few service interruptions, all brief. It has been very nice to work with companies that are smaller and easy to contact.

The one thing that we lost when we transitioned to our current setup is knowledge of how many people are using the SMCC internet. AT&T had a clear report about the numbers of WiFi users but that is not yet the case with Epsilon. This is a work in progress.

May 2022 Youth Report

Plans are underway for special summer activities for preschool and elementary age children who are out of school. Learning time on Tuesdays will be twice a month every other week beginning June 7th as well as special Monday Playgroup activities such as field day games and water play.

We received a grant for \$1,500 from Dollar General Literacy Fund to add award winning books and sequential readers to the SMCC Library. The grant will also fund some reading enrichment sessions this summer and opportunities for the children to learn to prepare simple lunch and snacks.

April activities included dying Easter eggs, older children learning to tie fishing flies, planting beans, stories and preparing for Spring Fling.

Math Camp has been occurring one Tuesday each month. The ages vary from 4 years to 8 years. In April, children continued work with skip counting, estimating, measurement and one to one correspondence.
